The Inclusive Socio-Economic Development in the Beni Mellal-Khenifra Region (ISED-BMK) project, funded by USAID, is seeking experienced volunteer consultants to contribute their expertise and make a lasting impact on the region's socio-economic growth. This is a unique opportunity to share your professional skills while helping strengthen local stakeholders and populations through capacity strengthening, training, and networking. By joining the ISED-BMK project, you will:

- Benefit from full coverage of travel expenses, accommodation, and per diem throughout the consultancy period.
- Directly contribute to meaningful, community-driven development in Morocco.
- Engage in cross-cultural exchanges that expand your global perspective.
- Gain hands-on experience in advancing economic growth, governance, and social inclusion.

Applications are welcome from volunteer consultants with expertise in governance, socio-economic development, civil society, business, entrepreneurship, regional development, and/or environmental management who are available for a **minimum of 10 working days between January 1 and July 31, 2025**. Volunteer consultants can be based in Morocco or any other country but <u>must</u> be willing to travel to the Beni Mellal-Khenifra region during the specified period. ### **ISED-BMK's Goals and Key Focus Areas:**

The ISED-BMK project, funded by USAID and implemented by FHI 360, aims to foster inclusive socio-economic development in the Beni Mellal-Khenifra region from 2020 to 2025. It seeks to equip women, youth, people with disabilities, and rural communities across Morocco with the tools, skills, and resources needed to promote equitable economic growth through active participation in local governance.

#### ISED-BMK seeks to:

#### 1. Enhance governance and inclusion

- Foster citizen participation in local governance and decision-making processes.
- Increase transparency and accountability in local government operations.
- Strengthen the role of civil society organizations (CSOs) in governance for greater inclusion of vulnerable groups.

#### 2. Drive economic growth through innovation

- Promote socio-economic inclusion of marginalized populations via entrepreneurship and innovation.
- Support the growth of businesses and job creation in key priority sectors.

By achieving these two goals, the project aims to establish sustainable decision-making processes that enhance livelihoods and foster inclusive economic development in the region.



## **Responsibilities and Expectations:**

As a volunteer consultant, you will:

- Provide expert advice and tailored technical support in key project areas, including civil society development, local governance, socio-economic inclusion, and business development.
- Facilitate training sessions, workshops, and capacity strengthening activities for local partners and institutions.
- Support the development and implementation of strategic initiatives in alignment with project goals.
- Collaborate closely with local teams, share insights, and help design sustainable solutions that can be carried forward by the local communities.

# **Eligibility Requirements:**

To be eligible for the volunteer consultant role with the ISED-BMK project, applicants must meet the following criteria:

- A minimum of 15 years of experience in relevant fields such as governance, socioeconomic development, civil society, business, entrepreneurship, regional development, and/or environmental management.
- A university degree in a related discipline (e.g., public administration, economics, social sciences, business, tourism, or environmental management). Advanced degrees or specialized certifications are a plus
- Demonstrated expertise in one or more of the areas of focus listed in the "Expertise We're Looking For" section.
- Fluency in English and French is highly preferred. Arabic language skills are a major plus for effective communication with local communities and stakeholders.
- Prior experience working in international development, with NGOs, or in multicultural environments is highly valued.
- Applicants must be available for a consultancy period between November 1, 2024, and May 31, 2025.
- Willingness to travel to the Beni Mellal-Khenifra region and engage fully in the consultancy work during the specified period.
- Strong communication, collaboration, and problem-solving abilities, as well as cultural sensitivity and adaptability, are essential.
- A strong commitment to making a meaningful impact on local communities and supporting inclusive development efforts.

- 3. Provide availability dates and level of effort (number of working days) for the consultancy period, which should be between January 1 and July 31, 2025.

#### **Additional Notes:**

- Applications will be accepted on a rolling basis.
- Once the initial screening is completed, the project team will discuss the specific scope of work with the volunteer consultant and agree on the implementation timeline.
- On-site consultancies requiring air travel must be at least 4 working days or longer, not to exceed 15 working days.
- Volunteer consultants will be responsible for acquiring visas and other travel related requirements as needed. The project will cover airfare, ground transportation, accommodation, and per-diem for the duration of the consultancy.
